Supporting United Nations political efforts on Ukraine

Total requirements: \$800,000

Introduction and Objectives

Global peace and security have seen a marked deterioration in recent years. Violent conflict has intensified, spreading throughout multiple regions of the world destroying lives, eroding social cohesion and undermining development gains. At the same time, heightened tensions between major powers have complicated responses to crises, weakening confidence in multilateralism and diplomacy. The world is now facing an increasingly complicated mix of protracted wars and emerging crises which require principled responses, sustained political engagement and effective mediation.

Against this increasingly difficult backdrop, the UN Department of Political and Peacebuilding Affairs (DPPA) plays a vital role leading United Nations efforts to prevent conflict and advance sustainable peace. As the United Nations political arm, we monitor political developments globally and provide critical analysis and guidance to Member States, regional partners and United Nations entities. By engaging in mediation and peacemaking efforts, the Department helps to lead timely and coherent responses to the world's most complex crises, including the ongoing war in Ukraine.

Despite this increasingly critical role, DPPA faces a severe funding crisis with voluntary contributions faltering in recent years. As demands rise, investments in the Multi-Year Appeal (MYA) — the Department's primary funding mechanism — remain among the most cost-effective measures for preventing conflict, far outpacing the immense human, financial and political costs of humanitarian aid and post-conflict reconstruction. Without sustained donor support, these critical functions and the United Nations ability to facilitate dialogue, reduce risks and bolster peace would be significantly constrained. At a time when substantial resources are being invested in humanitarian response and recovery, political engagement remains essential to creating conditions for sustainable peace. DPPA provides a unique United Nations platform for preventive diplomacy, political analysis and mediation support that complements, rather than duplicates, humanitarian and developments efforts.

Context

Now entering its fourth year, the war in Ukraine continues to exact a devastating human toll and generate a profound impact on international peace and security, global political stability and economic development. Despite intensified diplomatic engagements and increasing calls for a ceasefire and peace negotiations, the conflict continues to affect regional stability, global food and energy markets, nuclear safety considerations and broader international security dynamics. In this complex context, sustained diplomatic engagement remains crucial to advancing prospects for de-escalation and peace.

In support of the Secretary-General's good offices on Ukraine, DPPA plays a central role in creating and protecting space for meaningful dialogue. Through in-depth analysis, strategic planning and mediation support, the Department assists Member States, regional partners and entities across the United Nations system in navigating an exceptionally complex and fluid conflict environment. A core element of this engagement is the provision of timely reporting to the Security Council, General Assembly and United Nations leadership identifying emerging risks, as well as potential opportunities for productive peacemaking efforts.

DPPA's Liaison Office in Kyiv is a critical enabler of these efforts. Operating in an unpredictable and high-risk environment, the Office provides indispensable on-the-ground engagement with national and local authorities, international partners and civil society actors stay abreast of the constantly shifting context. This presence allows DPPA to maintain a real-time understanding of political, security and societal dynamics ensuring that Headquarters-level analysis and guidance are grounded in current realities.

Funded entirely through Multi-Year Appeal (MYA) resources, the Liaison Office is DPPA's only field presence dedicated to Ukraine and serves as the Department's principal source of real-time political analysis and engagement in the country. It enables DPPA to support the broader United Nations response in Ukraine by delivering continuous political monitoring, analysis and reporting, while also advancing cross-cutting priorities such as the Women, Peace and Security (WPS) and Youth, Peace and Security (YPS) agendas. The Office also advises the Resident Coordinator (RC) and UN country team (UNCT) on conflict-sensitive approaches to strengthen social cohesion, reconstruction and recovery programming.

Together, these efforts enhance the UN's ability to anticipate and respond to developments, align Headquarters and field efforts, and position the Secretary-General to respond effectively to emerging diplomatic opportunities, including potential ceasefire initiatives.

Progress in 2025

Against the backdrop of a rapidly evolving conflict in Ukraine, 2025 marked a year of steadfast engagement by DPPA. A strengthened field presence enabled sustained political engagement, timely and forward-looking reporting and targeted mediation support strengthening the United Nations ability to respond effectively to developments on the ground and to support principled efforts towards de-escalation and a lasting peace.

In November, Rosemary A. DiCarlo, Under-Secretary-General for Political and Peacebuilding Affairs, visited Ukraine to express solidarity with the Ukrainian people and reaffirm the call for a just and

lasting peace. The visit underscored DPPA's high-level commitment to inclusive dialogue and to the Secretary-General's good offices in support of peace efforts.

Informing Efforts at Headquarters

Throughout the year, DPPA leveraged the Liaison Office's presence in Kyiv to strengthen strategic coordination and decision-making at Headquarters. The Department continued to co-chair monthly meetings of the Inter-Agency Task Force (IATF) on Ukraine, providing strategic advice and coordination to more than twenty United Nations entities based on real-time field analysis. DPPA also coordinated the preparation of the Secretary-General's biannual report to the General Assembly on the human rights situation across the temporarily occupied territories of Ukraine, enabling an informed and principled global response to the ongoing conflict.

Our expert analysis and reporting also continued to inform decision-making and feed directly into Security Council briefings by the Secretary-General and other senior leaders across the United Nations. Throughout 2025, DPPA produced 55 analytical reports and prepared 15 substantive briefings for Security Council meetings, ensuring that United Nations leadership and Member States were equipped with timely assessments to respond to rapidly evolving developments.

Bolstering Impact in Ukraine

In Kyiv, the Liaison Office continued to provide conflict-sensitive political guidance to inform United Nations programming, particularly in relation to reconstruction and early recovery. Regular participation in UNCT coordination mechanisms ensured a coordinated and effective response to the changing situation on the ground and coherence across humanitarian, development and peacebuilding efforts.

Engagement with civil society actors remained central to advancing WPS and YPS priorities. A flagship

accomplishment was a dialogue titled “Voices of Ukrainian Women and Youth for Sustainable Peace in Ukraine” held in Kyiv in May 2025, which convened more than 80 participants from 13 regions. The initiative created a rare, structured platform for dialogue between women and youth leaders and national decision-makers, fostering mutual understanding and amplifying diverse perspectives on peace processes, recovery, social cohesion, and the Sustainable Development Goals. It helped ensure the constituencies often underrepresented in formal political processes are better positioned to contribute to future peace and recovery efforts. By bringing women and youth together, DPPA enabled cross-generational exchanges, identified knowledge gaps among civil society regarding formal peace processes, and strengthened bonds between local and national actors.

Targeted Mediation Support

Responding to requests from civil society partners, DPPA mobilized its Standby Team of Senior Mediation Advisors (SBT) to provide specialized expertise on women’s participation in mediation and ceasefire processes. In line with the Secretary-General’s ‘Common Pledge’ on women’s participation in peace processes, this targeted support worked to further develop the capacity of Ukrainian women leaders to engage meaningfully in future ceasefire-related negotiations.

Key Activities and Impact

In 2026, DPPA built on these foundations to ensure the United Nations remains agile, informed and prepared to support de-escalation and inclusive peace efforts in a highly dynamic and sensitive context. MYA funding will underpin the following priorities:

- **Sustain on-the-ground engagement:** A robust presence in Kyiv has continued to serve as the hub for DPPA's diplomatic engagement, maintaining close relationships with national authorities, Member States, regional organizations, and policy institutions to continually deepen understanding of the conflict and its global implications. Critical MYA funding ensures uninterrupted operations and the provision of high-quality reporting and briefings to inform United Nations deliberations and decision-making.
- **Enhance programmatic impact:** MYA funding has continued to enable DPPA to continue providing conflict-sensitive guidance to the Resident Coordinator and UN country team, strengthening the effectiveness of humanitarian aid and early recovery programming throughout the country, and ensuring alignment with peacemaking and peacebuilding objectives.
- **Respond to escalating tensions:** As political and security conditions evolve and require intensified engagement, DPPA remained prepared to deploy surge capacity, when required, to assess sudden developments, identify emerging risks and respond to potential openings for diplomatic engagement. This enhanced capacity will support internal coordination across the Secretariat in preparation for any potential negotiations, ceasefires, or peace arrangements, as they emerge.
- **Advance inclusive peace processes:** DPPA continued to deepen work on the Women, Peace and Security and Youth, Peace and Security initiatives, building upon successful engagements with civil society actors in 2025. Future funding will support follow-up workshops, dialogue platforms, and capacity-building initiatives to empower local actors to continue contributing meaningfully to the peace process and strengthen social cohesion at national and local levels.
- **Enable electoral support:** Ukraine has indicated that elections may be held across the country if political and security conditions allow. Should political, legal and security conditions future elections, DPPA stands ready, at the request of Ukrainian authorities, to provide technical electoral expertise and facilitate rapid deployment of a needs assessment mission as well as targeted surge capacity to support the RC and UNCT.

Together, these activities will ensure that DPPA remains at the forefront of United Nations efforts to prevent escalation, support inclusive peace processes, and position the Organization to respond effectively to emerging opportunities for peace in Ukraine.

Funding needs

The complexity of the conflict in Ukraine calls for principled action and sustained investment.

Continued donor support will be essential to consolidate the gains DPPA achieved in 2025 and translate them into meaningful opportunities for de-escalation and peace efforts. A fully-funded MYA helps facilitate follow-up to the Pact for the Future, which urges the Secretary-General to actively use his good offices and ensure that the United Nations is adequately equipped to lead and support good offices, mediation and peacemaking.

DPPA is seeking USD 44 million in 2026 to sustain its prevention, peacemaking and peacebuilding work. As of June 2026, the Multi-Year Appeal is only 50 per cent funded. Closing this funding gap is essential to ensure the Department can continue delivering on its mandates and responding effectively to evolving crises. Within this appeal, \$800,000 is sought to support DPPA's engagement on Ukraine.

The requested amount will enable DPPA to maintain its field presence in Kyiv, provide timely political analysis and strategic advice, support inclusive dialogue and remain prepared to respond rapidly to emerging diplomatic opportunities. At a time of continued uncertainty, this investment will help ensure that the United Nations remains an effective and credible partner in support of de-escalation and a just and lasting peace. The funding will help ensure that the Secretary-General remains equipped to exercise his good offices. Without sustained funding, the progress made by DPPA in laying the foundations for lasting peace in Ukraine could be significantly undermined, increasing the risk of escalation, regional spillover and worsening global peace and security.

The requested funding represents a highly cost-effective investment in preventive diplomacy. For a relatively modest contribution, donors will enable the United Nations to maintain an in-country political presence, provide strategic analysis to decision makers, support inclusive dialogue and maintain preparedness for rapid response to emerging opportunities for de-escalation and peace efforts.
